# 2. OBJECTIVES AND LEARNING OUTCOMES

#### **Objectives**

Religion is one of the oldest and most complex cultural formations, which played a significant role in shaping daily life, institutions and relationships of human (communities), affecting our values and way of life. The course examines what religion meant and means for human communities and for individuals, and what level of religiosity exists. Within this, it raises the question of the relationship between religion and morality, and describes the moral guidance of several major religions.
